## VACANCY ANNOUNCEMENT

### CALL FOR EXPRESSION OF INTEREST FOR APPOINTMENT AS JUDGE OF HIGH COURT OF JUSTICE, DELTA STATE

Pursuant to Rule 3 of the 2014 Revised Guidelines for the Appointment of Judicial Officers of All Superior Courts of Record in Nigeria, and following the announcement of vacancies in the office of Judge of High Court Bench for Delta State Judiciary, the Judicial Service Commission, by this notice, hereby calls for expression of interest from suitable candidates for appointment as Judge of High Court of Justice, Delta State.

#### 2.0. REQUIREMENTS/COMPETENCIES.

- 2.1. To be eligible to apply for this appointment, the candidate must satisfy the following minimum requirements.
- i. Applicant must be a legal practitioner in Nigeria and has been so qualified for a period of not less than ten (10) years with considerable knowledge and experience in the practice of the Law;
  - ii. Applicant must be less than 65 years of age;
  - iii. Applicant must be of good character and reputation with strong traits of diligence, hard work, honesty, integrity, sound knowledge of law and consistent adherence to professional ethics;

- a). active successful practice at the Bar, including satisfactory presentation of cases in court as a Legal Practitioner either in private practice or as a Legal Officer in any Public Service and/or;
  - b). Satisfactory and consistent display of sound and mature judgment in the office as a Chief Registrar, Deputy Chief Registrar, President or Chief Magistrate and/or;
  - c). Credible record of teaching law, legal research in reputable University and publication or legal works.
